AFFIDAVIT FOR LAWFUL PRESENCE VERIFICATION

CONTRACTOR LICENSE CLASSIFICATIONS & FEES

G-General Contractor: This contractor is one who builds one (1) or more dwelling units or commercial or similar business type buildings per year. **\$150.00**

B-Building Contractor: This contractor is one who is in the business of remodeling, fix-up type construction, roofing, siding, concrete, excavations, demolition or other work requiring permits under the International Building Code or regulated under other related Codes and Ordinances as adopted by the City of Fort Lupton. **\$75.00**

H-Heating, Ventilating, and Air Conditioning: This contractor is one who is involved in installing furnaces, heaters, ventilating equipment, air conditioning, or other work requiring permits under the Mechanical Code or regulated under other related Codes and Ordinances as adopted by the City of Fort Lupton. **\$75.00**

P-Plumbing Contractor: This contractor is one who is involved in plumbing that requires permits under the Plumbing Code or is regulated under other related Codes and Ordinances as adopted by the City of Fort Lupton. A copy of your current Master Plumbers License as issued by the State of Colorado must be submitted. **\$75.00**

E-Electrical Contractor: This contractor is one who is involved in electrical work that requires permits under the National Electrical Code or is regulated under other related Codes and Ordinances as adopted by the City of Fort Lupton. A copy of your current Master Electricians License as issued by the State of Colorado must be submitted.

No Annual Fee

HM-House Movers: All buildings to be moved within the City Limits of Fort Lupton shall be inspected by the Building Official prior to the move. Approval by the Building Official is required prior to any permit being issued for the relocation and rehabilitation of the building within the City Limits of Fort Lupton. Any building approved by the Building Official will be required to meet the same standards as new construction.

The following fees for moving of buildings shall be charged:

1. A seventy five dollar (\$75.00) inspection fee shall be payable for each building inspected for the purpose of moving the building to a location within the City Limits of Fort Lupton, excluding mobile houses and modular homes.
2. In the event the move originates outside the City of Fort Lupton, a mileage fee charge of thirty cents (\$.30) per mile shall also be imposed. This fee shall be calculated based on an estimate round trip distance to and from the location of the building to be moved.
3. All fees included in this Section shall be payable prior to inspection of the building.
4. These fees are in addition to normal building permit fees.

T-Tree Trimming License: \$5.00 per year
